WATTS TOWNSHIP, September 1, 2010

The Watts Township Board of Supervisors met in regular session at the Watts Buffalo Community Center at 6:30 PM. Present were Karl Raudensky, Charlie Louden, Pat Gutheil, Wendy Brunner and several residents.

The minutes of the August meeting were read and approved. Gutheil /Louden

Good and Welfare:

Mr. Ted Engle, representing New Buffalo Borough, addressed the Board of Supervisors regarding their failure to submit a land development plan. Mr. Engle said he didn't know they needed to submit a plan and was concerned they were not contacted prior to this time to do so. The electrical components are located in the pre-existing building on the land; the entire Chromaglass collection system is underground; they removed a small shed and will place a propane tank on that concrete pad. Mr. Louden expressed concern regarding the two existing dwellings on the same property as this development. Mr. Spease felt the residences would be grandfathered in but if the dwellings hooked into the sewer system, a sewer module would need to be submitted to DEP; he will review page 10 of the Site Plan. Solicitor Fenicle will be contacted to offer his opinion as to whether underground utilities generally require a land development. Mr. Engle will share the full plan with Supervisor Gutheil. He has also agreed that New Buffalo will submit a land development plan if Solicitor Fenicle so indicates.

Old Business:

Regarding the Act 537 Plan, DEP has been contacted and a workshop is set for September 8, 2010 with the Board to discuss the content of the RFQ.

The Board discussed the creation of a policy to handle complaints. 3 options were presented by discussion: submission of complaint to the Township and the appointed official simultaneously; submission to only the appointed official; submission to only the township office. After a lengthy discussion, a motion was made by Charlie Louden, second by Raudensky, that all complaints shall go through the Township Office, be logged in them disseminated to the appropriate person. Raudensky and Louden in favor; Gutheil dissenting. Addition discussion resulted in the directive that the Board of Supervisors will also receive a copy of that complaint.

New Business:

The Board decided that both Liquid Fuels CD's will be cashed in, as they come due, September and October and deposited in the Liquid Fuels account in anticipation of the fall paving project.

Roadmaster:

Routine maintenance is being performed. Fulkroad will pave township roads in late September.
